

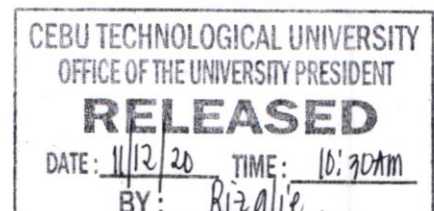

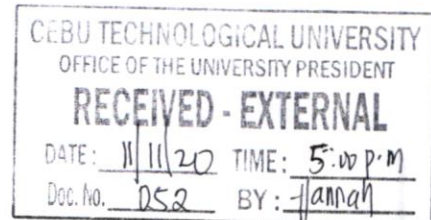

Dear **Dr. Ancheta**:

On the basis of our validation of your institution's status with the Commission and accreditation with the Bureau of Immigration, the Commission *en Banc* (CEB) through Resolution No. 699-2020 confirmed the admission of new international students for the 1<sup>st</sup> semester of AY 2020-21 by Cebu Technological University, Cebu City.

The Commission would like to remind the Institution that the full online learning arrangement is temporary and shall only be implemented in the 1<sup>st</sup> semester of AY 2020-2021. The international students are expected to arrive in the Philippines by the second semester or once travel restrictions are lifted and visa issuances by the Department of Foreign Affairs (DFA) resume. The HEI is likewise required to submit the names of international students admitted by the institution under this arrangement.
